### Will Ponting opened the meeting and welcomed everyone

- 32 members and guests attended the meeting
- Apologies were received from several members
- Will provided a bit of history for the group and highlighted some of the additional things that had been introduced including formally audited accounts, Newsletter, website and most importantly over 80,000 records in the database. It was stressed that submitting records was one of the most effective things individuals can do to support bat conservation in the county.

#### WBG Committee vacancies.

There was no formal voting. Voting for committee roles will be sue in Spring 2024.

Kelly Sheldrick has officially stood down as Events Officer and the Committee would like to thank her for sterling work over the past few years in the role.

Will noted that the current committee was rather minimal and put out an appeal for help particularly for an Events Office, stressing how much more could be achieved for the wider membership if this role could be filled. He gave a general outline what that role could involve: Public engagement with individuals and organisations through events and social media, training of group members via talks or events. He stressed that all committee roles are voluntary and flexible depending on the abilities, interests and availability of those taking them on. (Subsequent to the meeting an Events Officer role description has been drawn up).

Will outlined how the Committee can support members particularly through small grants and detector loans.

Will gave his report on the year's financial activity.

In summary the WBG funds remain at a good level.

Small grants are available to members for bat survey work, DNA testing and other bat related activities. Any requests to be sent to The Treasurer. Will provided a quick summary of grants and donations made so far in 2023.

Debbie Harwood asked if funds might be available towards a Bat Cage at the Wiltshire Wildlife Hospital, Will said a contribution could certainly be available and asked Debbie to contact him directly.

Will reported that the bat group had 263 members which was healthy despite 44 non-renewals so far during the year.

#### **Update on Events**

As previously stated the Group is currently without an Events Officer. However, Will was able to report that Avon Bat Group have invited WBG members to join their series of Zoom Talks taking place over the Winter. Laura Loncar will be sending out information on these via email. On Facebook and on the Website.

Bat Group Member and Graphic Designer, Richard Cassidy, will be putting together three walks leaflets which will be available online. And there will during the Spring and Summer of 2024 there will be Guided Walks set up at each location to launch the leaflets.

# Update from the County Recorder – Gareth Harris

Gareth gave a brief run down of the highlights of bat work activity over the past few months. You can read the details of these projects on the Wiltshire Mammal Portal under the WBG publication tab. www.wiltshiremammals.wordpress.com.

- 1. 2023 was another productive field season for the Group's bat work; significant delivery in the Savernake Forest, Trowbridge Woodlands, Cotswold Water Park and South Wiltshire Greater Horseshoe Bat Project.
- 2. Ring movements of note include:
  - a. RSPB Franchises Lodge new confirmed Bechstein's maternity colony & 30km ring movement of Bechstein's from Chilmark Quarries SSSI to New Forest. Thanks to Ian Davidson-Watts and Chris Diek for sharing this information.
  - b. Greater horseshoe bat, movement from Winsley Mine SSSI to Hilperton, Trowbridge.
  - c. Bechstein's bat, retrapped in Cotswold Water Park on same site as ringed in 2009.
- 3. Species of note:
  - a. Nathusius' pip recording bat box check in Cotswold Water Park again
  - b. Regular encounters of Barbastelle bat maternity group in Savernake Forest
- 4. Surveys of note:
  - a. Forestry England funded a Savernake-wide bat acoustic survey, to be followed in 2024 by more radiotracking studies
  - b. Bentley Wood Charitable Trust funded a large bat acoustic survey.
  - c. Woodland Trust commissioned further work at Avoncliff Wood, including static detector work and trapping surveys, which resulted in further captures of Barbastelle and Bechstein's bat.
  - d. Wylye Valley Farmer Group commissioned landscape-wide bat acoustic surveys.
  - e. Together these projects have resulted in considerable volumes of bat records for previously underrecorded areas.
- 5. South Wiltshire Greater Horseshoe Bat Project
  - a. A few more dung beetle surveys (records of over 11,000 beetles)
  - b. Bat house has now been colonised by GHS, mostly as a night roost/feeding perch, but also by Mnatt.
  - c. GHS recorded for first time at a small swarming site near Salisbury....
  - d. Chilmark & Fonthill et al (GH, LMW et al).
  - e. Acoustic surveys commissioned to survey with Wylye Valley with the farmer group, generating data across 8 farms, especially for Bbar but also Rhipp, Rferr and Nathusius' pip! Pillboxes and land-scape connectivity the next steps here.
  - f. The Cathedral monitoring ongoing.

Members are encouraged to submit all bat records, via iRecord or our excel template recording form.

Fiona Mathews gave an outline of a new tool available online to bat workers the Horseshoe Bat Flight Line Predictor. Available from the Mammal Society via: https://batdispersion.mammal.org.uk

This system works by helping predict the probable routes bats may take in a landscape and therefore provide guidance on where to position recording devices.

### Wiltshire Bat Group Principles

- Bat Group members should respect and adhere to National Guidelines relating to personal safety and bat welfare at all times.
- Bat group members engaging with, referencing or representing the Wiltshire Bat Group to the media should ensure they are delivering accurate, balanced and consistently professional messages aligned with the values of the group, and national bat conservation initiatives.
